I, the above-named petitioner, request the release of a custodial law enforcement agency recording to see Ex. 1 attached hereto state that at least some portion of the law enforcement agency recording was made in this county, and I further state the following: this Petition supplements and renews the Petition filed by this Petitioner in this cause on April 26, 2021, which is incorporated herein by reference, and seeks an order allowing the release of the PCSO recordings made April 21, 2021 that the Court ordered be disclosed by the Amended Order entered in this cause on May 7, 2021 (the "Amended Order", incorporated herein by reference), by which the Court ordered PCSO to disclose to Khalil Ferebee specific portions of the PCSO recordings as described and listed in para. 3 (and specifically parts a. through e. thereto) of the decretal part of the Amended Order (the "Disclosed Recordings"). The Amended Order required that the Disclosed Recordings be blurred to prevent identification pending completion of any internal and criminal investigations. The Amended Order also provided that it did not "prevent reconsideration of release of the videos at a later time, upon the conclusion of both internal and criminal investigations arising from the incidents." The internal and criminal investigations arising from the incidents have now been concluded. Petitioner respectfully seeks an order allowing release of the Disclosed Recordings pursuant to N.C.G.S. 132-1.4A(g), without redaction, at this time.
