I base my belief on the following facts: (Print ALL information clearly.)

On behalf of the Hampton Roads Regional Jail, the Internal Affairs Division is seeking criminal charges against Sergeant Tearsha Jones for intentionally defrauding the agency and receiving \$2,104.55 in overtime payments under false pretenses.

On Saturday June 12, 2021, at 06:13, Hampton Roads Regional Jail Sergeant Tearsha Jones reported for overtime duty, clocked in using the agency's time management system, and immediately left the premises. Later that evening at approximately 19:22, Sergeant Jones returned to the premises, clocked out using the time management system, and departed for the evening. Sergeant Tearsha Jones received \$451.00 in overtime compensation from the Hampton Roads Regional Jail for a total of 12.50 hours that she did not actually work.

An ensuing internal investigation determined that Sergeant Tearsha Jones falsified or manipulated the agency's time management system with intent to defraud, on at least 10 different occasions from February 15, 2021 – July 04, 2021. During this time period, Sergeant Tearsha Jones received payments totaling \$2,104.55 in overtime compensation from the Hampton Roads Regional Jail for 61.25 hours that she did not actually work. End of summary.

The statements above are true and accurate to the best of my knowledge and belief.

In making this complaint, I have read and fully understand the following:

- By swearing to these facts, I agree to appear in court and testify if a warrant or summons is issued.
- The charge in this warrant cannot be dismissed except by the court, even at my request.
