On 01/19/2022 an Officer was at Maryview Hospital when a gold color vehicle pulled up to emergency room entry door with young male suffering from a gunshot wound (GSW). The juvenile male was rushed into the trauma room with a single gunshot wound (GSW) to the back which was life-threatening injury. Maryview medical staff provided live saving measure before transporting the victim to Sentara Norfolk General Hospital (SNGH) at 1625 hrs. When medics arrived at Sentara Norfolk General Hospital the victim was rushed into the trauma bay where he succumbed to his injury and doctors pronounced the victim deceased at 1636 hrs. The victim was identified as . Detectives started the investigation and it was determine the shooting occurred at 1401 Elmhurst Ln, Portsmouth, VA which is Manor High School. A witness told Detectives he observed a gold vehicle with 4 students who are member of the basketball team leaving the school parking lot and that's when he heard 3 shots in his immediate vicinity and the witness turned toward the sound of the gunshots he observed three individuals on bikes. The witness stated he observed making a concealing motion to the front pocket of the hoodie immediately after the shots. The witness is familiar with the three suspects as well as the victims. The witness was able identify all three suspects because he encounter the suspects earlier in the day and the witness told the suspects they were not allowed on the property if they didn't attend the school. The suspects were identified as , 2nd suspect was identified as Melvon Deshawn Parker, B/M, DOB: 1 3rd suspect was identified as Kwendale Glenn, B/M, DOB: . The witness is a staff member of Manor High and has encounter victim and suspects numerous times. Request petitions for 1st degree murder, UFA, Possession of Firearm on school property, Underage Possession of firearm Request warrants for 1st degree murder, UFA, Possession of Firearm on School Property, Shoot, in committing or attempting a felony on Melvon Parker and Kwendale Glenn
