I base my belief on the following facts: (Print ALL information clearly.)

On March 27, 2022 at approximately 22:15 hours, Uniform Patrol responded to the intersection of Townsend Place and Ashmeade Court in reference to a person with a gun. The complainant, Mr. Reginald Thorne III, advised the dispatcher that two individuals with guns approached their vehicle, then left in a blue truck displaying out of state tags.

Uniform Patrol responded to the side entrance to 6550 Hampton Roads Parkway (The Cove Veterinarian Hospital) from Respass Beach Road. Officers observed the vehicle to be occupied by two, later identified to be Mrs. Tameisha L. Rogers (the driver) and Mr. Reginald A. Thorne III (the passenger). Mrs. Rogers was unresponsive, had agonal breathing, and no pulse. Mrs. Rogers was pronounced deceased on scene.

On March 28, 2022 during a canvass of Townsend Place, where the victims had been prior to the shooting, contact was made with a resident on Townsend Place who had information about the shooting. Phillip Etheridge, describes the shooting and seeing what happened.

On March 29th Mr. Phillip Etheridge came to Police Headquarters and provided a recorded statement. Prior to the incident, Etheridge admitted to calling the four other co-conspirators to have them to come to his location. He also admitted to driving his vehicle, which was used by the co-conspirators to shoot from while they pursued the victim's vehicle. He identified an offender known to him as the shooter. He was advised by the shooter to follow the victim's vehicle (Nissan Rogue). He stated that while traveling down Respass Beach Rd, the shooter had an assault style weapon and hung out of the passenger side window of his vehicle and discharged it at the victim's vehicle. He stated that the shooter fired numerous times. At the time of the shots being fired, the accused's vehicle was within ten feet from a Suffolk Public School.

The accused advised that he then fled the area of the offense. He advised on the following day, he and the shooter purchased cleaning supplies and took his vehicle to be thoroughly cleaned to remove any evidence.

The statements above are true and accurate to the best of my knowledge and belief.

In making this complaint, I have read and fully understand the following:

- By swearing to these facts, I agree to appear in court and testify if a warrant or summons is issued.
- The charge in this warrant cannot be dismissed except by the court, even at my request.

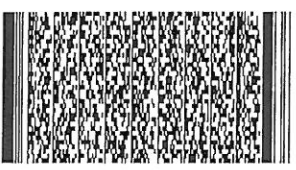
