The defendant was present and represented by counsel.

On September 27, 2000, the defendant was found GUILTY of the following offense (s):

Malicious Wounding (F)	04/13/00	18.2-51
Use of a Firearm in the Commission of a Felony (F)	04/13/00	18.2-53.1

The presentence report was considered and filed as part of the record in accordance with the provisions of Code § 19.2-299.

The Court reviewed and considered the applicable discretionary sentencing guidelines and made the completed worksheet a part of the record of the case pursuant to the provisions of Code § 19.2-298.01.

Before pronouncing the sentence, the Court inquired if the defendant desired to make a statement and if the defendant desired to advance any reason why judgment should not be pronounced.

The Court **SENTENCES** the defendant to:

Incarceration in the Virginia Department of Corrections for the term of: 10 years for Malicious Wounding and 3 years for Use of a Firearm in the Commission of a Felony.

The Court **SUSPENDS** 10 years of the sentence for Malicious Wounding conditioned on the following:

1. **Good behavior.** The defendant shall be of good behavior for 13 years.
2. **Supervised Probation.** The defendant is placed on Supervised Probation and the defendant shall comply with all the rules and requirements set by the Probation Officer. **LENGTH OF PROBATION:** Until released by the Probation Officer. **PROBATION TO BEGIN:** Upon release from confinement.

3. **Other.** Upon his release from confinement, the defendant shall be required to provide support for his children.

Payment after release. \$ 696.00 Costs. Payment to be made after defendant's release from confinement.

Credit provision when time to be served. The defendant shall be given credit for time spent in confinement while awaiting trial pursuant to § 53.1-187.

The defendant shall report to the Virginia Beach Correctional Facility on December 1, 2000 at 9:00 pm to begin the period of active incarceration
