The victim shared an Uber account and cash app with her Aunt Jeanie Bailey, on 1/11/23 the victim received a cash app money transfer for \$30 from Lukas Duke and immediately placed an Uber ride. Andarius McClelland was the last person that we can connect to the victim prior to her death. There were numerous items that were found around the body that could contain DNA, McClelland's sample will be compared to the DNA profiles on the items.

On 01/17/2023 Sgt Coughlin interviewed [redacted] who stated that his brother Andarius McClelland was at his apartment at [redacted] with the victim Aonesty Selby the night of her disappearance. [redacted] stated that his brother Andarius borrowed his 2021 Dodge Charger with [redacted] to give Aonesty a ride home. [redacted] also stated that his vehicle was covered in dirt which is consistent with the dirt on the path our victim was located deceased on. During the interview [redacted] stated that he owned a Glock 9 MM pistol that he kept in his nightstand drawer. After the interview Inv Lacy spoke [redacted] VIA landline and he stated that his brother Andarius attempted to sell this firearm to a friend identified as [redacted]. [redacted] stated he confronted Andarius about the location of the firearm once he noticed it was missing. Andarius told [redacted] that he needed to get rid of the gun and sold it to [redacted]. [redacted] contacted [redacted] and retrieved the firearm.

Inv Lacy interviewed [redacted] who stated that on Friday January 13<sup>th</sup>, 2023 that Andarius contacted him in reference to selling firearm. [redacted] and Andarius met and exchange the firearm. [redacted] stated that the firearm was given to him in a plastic grocery bag. [redacted] stated that the firearm was a glock 9MM. On Monday January 16<sup>th</sup>, 2023 [redacted] was contacted by [redacted] and returned the firearm to him.
