Good Morning Board Members,

I wanted to process the entirety of the Work Session Meeting from February 12th before I reached out with my thoughts and concerns. I am sure you have all had to respond to a ton of emails and Let's Talk messages after that meeting. Here are my concerns and questions.

- 1. Communication. It is very clear that the 5 board members are not on the same page and are not in regular communication. Mrs. Fairman, Mrs. Goodwin, and Mr. Pajevic appear to be communicating with one another before the meetings and have a separate agenda from Mr. Shafer, and Mr. Richardson. Will you commit to mediation amongst the board members to create a cohesive working board?
- 2. Political Agenda. I have a clear understanding of your 3 person agenda because you have made public statements and posts about what your agenda is. On separate occasions, you have each made comments (verbally or written) that you question the science behind the Covid response, "wokeness" and "indoctrination," and have actually responded "YES," to the question, "Would you vote to fire Dr. Shandor." Mrs. Fairman, you attempted to backpedal and spin what you said, but it was recorded. Mrs. Goodwin, in a Facebook post, you wrote, "Shandor is a piece of Shit who bows down to the will of the VDOE and NEA. I want him fired." Do you still have this opinion? Would you clarify this statement? Mr. Pajevic, you stated in a campaign text message that you want to "protect our children from harmful far left agendas." Will you please explain what that means?
