**Stipulation Of Commonwealth's Evidence**

The Commonwealth's evidence would establish that on December 15, 2017, [REDACTED] discovered numerous tools missing from his vehicle parked in Virginia Beach. The tools valued at over \$200.00, included an air compressor, framing nail gun, trim nail gun, a Dewalt tool bag with various tools, and a Bosch tool bag with various tools. Later that same day he saw the missing tools being sold on the OfferUP website with a picture of the seller identified as "Punnie". Virginia Beach Detective I. Yager gathered information from OfferUP as to the email site associated with the seller's account. The email came back to [draytonashawnda@gmail.com](mailto:draytonashawnda@gmail.com). Upon further investigation into associated accounts and jail calls intercepted between the defendant and her mother who was incarcerated as of December 23, 2017, the person associated with the account was in fact the defendant. The defendant's mother called her "Punnie" in the telephone calls.

Lloyd O. purchased some of the stolen tools from "Punnie" for \$160.00, including the air compressor, framing nail gun, and trim nail gun. He returned those to Det. Yager and she returned them to Mr. Handley.

Claude M. purchased some of the stolen tools from "Punnie" on December 15, 2017. He went to a residence in Norfolk where he paid \$150.00 for the Dewalt tool bag with various tools, including drill bits, brushes, wrenches, and the Bosch tool bag with various tools including screwdrivers, nails and an impact driver drill. She told him at the time that her grandfather had just passed away and she had a warehouse full of tools she had to figure out what to do with. He returned the tools to the detective and the recovered tools were returned to [REDACTED]

Thereafter on December 23, 2017, the defendant, Tashawnda Nicole Drayton, entered the Macy's at 701 Lynnhaven Parkway in Virginia Beach. While inside, she and three other people walked through the store selecting various items. The defendant's

mother had many items of clothing including jeans and shirts valued over \$900.00. Her mother removed her coat and placed it over the items on her arm. She handed her car keys to the Defendant her before they walked out of the store without paying for the items.


Store security officers [REDACTED] and [REDACTED] stopped the defendant's mother outside of the building. She struggled with security. The defendant and the two others fled. While the struggle continued, a one of the security personnel noticed a red SUV coming at them. The defendant had fled to the car, got into the red SUV, and drove it toward the security officers. They had to jump out of the way and pull the defendant's mother out of the way to avoid being run over by the defendant. The defendant ended up crashing the red SUV into the planter boxes just behind where the defendant's mother was being taken into custody outside of Macy's. The SUV and the brick planter sustained damage. Damage to the brick planter was \$3,100.00. The defendant drove off, and she appeared to head toward them again. However she changed paths and quickly sped off across the parking lot.


Store security took the defendant's mother and the merchandise into the security office. The jacket was on the pile of stolen merchandise. Loss prevention was going through the stolen merchandise valued at \$914.00.
